Bids received after this date and time will not be accepted. Bids will be opened and publicly read aloud. Bids received will be awarded by the city following bid tabulation and contractor verification. Bidders are required by law to be registered with the State of Iowa. **Each bidder must have a completed contractor application form, must provide proof of Iowa Department of Public Health relevant training/certifications and proof of current insurance on file with the City of Marshalltown.**

Bids will be totaled on a lump sum and unit price basis. Change orders must be approved by the City of Marshalltown staff. **A pre-construction meeting will be held within thirty (30) days of bid award.** Work shall not commence until all materials have been received and the start date has been arranged with the City. All work shall be completed within 10 business days, weather permitting. Up to 3 payments will be made to the contractor on any given job; two partial and one final. Work will be monitored and inspections will be complete before payment is approved. Payments will be made by the City of Marshalltown.

By virtue of statutory authority, preference will be given to products and provisions grown and coal produced in the State of Iowa and to Iowa domestic labor to the extent lawfully required under Iowa statutes provided that award of said contract will be made to lowest responsible bidder submitting lowest responsive bid, which shall be determined without regard to state or local law, whereby, preference is given to factors other than amount of bid.
